

May 17, 2011

The Juniata County Commissioners met on the above date with Commissioners Jeff Zimmerman and Teresa O'Neal present. Commissioner Shelley was unable to attend. Also attending were – Coroner Lee Snyder and Planning Director Dave Bardell; members of the public Bob Reynolds and Gary Tweedlie; representing Juniata County Emergency responders - Jackie Leister, Carrie Lance, Darren King, James King, Shawn Luse, Robert Zimmerman, Tim Nilson, Samuel Graybill, Jr. and Marvin Esh; Times reporter Paulette Forry, Juniata Sentinel reporter Sheila Yorks, and Lewistown Sentinel Reporter Micaiah Bilger.

The meeting was called to order at 10:00 a.m. by Commissioner Zimmerman. A moment of silence was observed followed by the Pledge of Allegiance. On motion of O'Neal/Zimmerman, the Minutes of the May 10th meeting were approved as submitted.

Snyder was present to provide an update for his department. The Coroner and his Deputies attended a six-week course at the Police Academy. Act 122 money was used to fund the training.

Bardell submitted copies of the 2010 Planning Commission Report. He indicated that a class will be held for townships pertaining to road and bridge posting and bonding. Bardell, acting as Solid Waste Coordinator, stated that a date will be scheduled for e-waste recycling. He also noted that a Flood Plain Ordinance has been received by the townships.

- On motion of O'Neal/Zimmerman, approved checks #32,291 through #32,350 in the amount of \$44,664.93.
