

March 4, 2014

The Juniata County Commissioners met on the above date with Commissioners Jeff Zimmerman, Robert Reynolds and Teresa O'Neal present. Also attending were Sentinel reporter Julianne Cahill, Juniata Sentinel reporter Fonda Henry and Juniata County Planning Director Bradley Kerstetter.

The meeting was called to order at 10:00 a.m. by Commissioner Zimmerman. A moment of silence was observed followed by the Pledge of Allegiance. On a motion by Reynolds and a second by O'Neal, the Minutes of the February 25, 2014 meeting were unanimously approved as submitted.

There being no public comment, the Commissioners took the following actions:

- It was moved by O'Neal and seconded by Reynolds to approve the "Juniata County Sheriff Service Agreement" between the Juniata County Sheriff's Department and the Juniata County Domestic Relations Section. The term of the contract is January 1, 2013 through September 30, 2015. The motion was unanimously carried.
- It was moved by Reynolds and seconded by O'Neal to approve the tax exonerations for the following municipality as per the material provided. The motion was unanimously carried.
 - Fayette Township (with one exception)
- It was moved by O'Neal and seconded by Reynolds to approve the County Children & Youth Social Services Programs Certification Statement of receipts and expenditures for July 1, 2013 through December 31, 2013 as prepared by Robyn Ventresca, Children & Youth Fiscal Assistant. The motion was unanimously carried.
- It was moved by Reynolds and seconded by O'Neal to approve the execution of the "Federal Fiscal Year 2014 Hazardous Materials Emergency Preparedness Grant Agreement" as submitted by Allen Weaver, Emergency Services Director. The motion was unanimously carried.
- It was moved by Reynolds and seconded by O'Neal to approve the use of the County Records Improvement Fund to purchase one HP LaserJet P3000 P3015DN laser printer at a total cost of \$749.99 for the Treasurer's office as submitted by Sandra F. King, Juniata County Treasurer. The motion was unanimously carried.
- The Commissioners listened to a presentation by Brad Kerstetter regarding the Juniata County Workcamp scheduled for June 22nd through June 28th 2014. Following the presentation, the Commissioners expressed enthusiasm for the Workcamp and discussed various means of support.
- It was moved by O'Neal and seconded by Reynolds to approve checks #39559 - #39604 in the amount of \$155,111.00. The motion was unanimously carried.
- It was moved by Reynolds and seconded by O'Neal to approve checks #39605 - #39687 in the amount of \$1,085.40. The motion was unanimously carried.

There being no further business, it was moved by Reynolds and seconded by O'Neal to adjourn at 10:16 a. m. The motion was unanimously carried.
